The meeting was called to order at 6:00 p.m. by John Sistarenik. The July meeting minutes were reviewed and accepted by Mary Rose Evans and seconded by Pete Levermore.

Part 150 NCP:

A. Updates:

<u>Phase 1, 2, 3A, 3A-1:</u> Sound insulation is complete. To date 179 of 688 families have received sound insulation.

Phase 4A: Sound insulation for 50 families was awarded at the November board meeting. Construction is almost complete.

<u>Phase 5:</u> A contract to provide Sound Insulation for 85 families was awarded at the January board meeting. Measurement walk-throughs were completed in May. Construction is currently underway.

<u>Phase 4B:</u> Sound insulation for 71 families was awarded at the February board meeting. Measurement walk-throughs are complete. Construction begins in the fall.

Phase 6: Sound Insulation for 60 families. The project was advertised on March 9th. Phase 6 was awarded at the April Board meeting. Construction should begin by the end of the year.

Phase 7: Sound Insulation for 66 families. The project advertised on May 4th. Contract was awarded at the June board meeting. Construction will begin the first part of 2015.

Phase 3B: Awaiting easement resolution.

B. Contraflow Exceptions: Contraflow for July was, 79% for arrivals from the south and 85% for departures to the south. In August, arrivals from the south were 61% and departures to the south were 92%. For CY-2014 the arrivals are averaging 65% and the departures are averaging 84%. A daily summary for July and August 2014 is contained in the handout. A monthly summary going back 8 years is also included in the handout.

Current Noise Concerns:

- **A.** Report on Noise Concerns/Complaints: We received a total of 22 comments in July. The QHP project office received 10 comments and 12 comments were received by the LRAA. In August we received a total of 11 comments, 4 were received at the QHP project office and 7 were received by the LRAA.
- **B.** <u>Runway Utilization</u>: Runway utilization percentages for July and August are contained in the handout. Daily runway utilization and comments from the Air Traffic Control Tower for July and August are also included in the handout.
 - Fort Knox Restricted Airspace (R-3704): Under certain conditions when restricted area 3704 is active, Air Traffic Control (ATC) requires that arrivals come in from the north in order to avoid a 3 nautical mile buffer around the airspace. In July and August an exercise at Fort Knox required activation of the 3 nautical mile buffer on consecutive days and nighttime arrivals were required to utilize runway 17 L/R (arrive from the north). Our concern is that activity in the restricted area may be increasing and therefore could cause a reduction in the use of Contraflow (for arrivals). Local ATC has been working to keep us informed of the times when contraflow activity will need to be suspended because of activity in R3704. We have asked our Airports District Office (ADO) in Memphis for assistance with this issue. The ADO has asked the FAA Operations Support Group in Atlanta for guidance and they are currently reviewing this issue.
- C. Construction and Maintenance Activity: Construction for taxiway "A" Bid Package 5 is nearing completion. The taxiway will be operational November 1st. The 2014 Pavement Rehab project is underway. This project mostly impacts the west runway but there will be some asphalt shoulder work that will impact the east runway. Closures of the runways will occur during off-peak times. Runway 11-29 Safety Area Improvement project is about 75% designed. We plan to receive bids in January 2015. Project includes installation of an EMAS bed, construction of a tunnel for the service/perimeter road, relocation of Runway 29 localizer and pavement rehabilitation/reconstruction. Construction phasing plans are currently under review and will be discussed over the next several weeks to minimize airfield impacts and maximize constructability.

<u>Announcements:</u> John Sistarenik suggested the group think about nominating someone for the Fly Quiet Award which will be awarded at the November Holiday meeting. Bob


Slattery announced that he has spoken with Ms. Elsa Haddad, who is interested in becoming the Southern Indiana representative.

Guest Comments: Shane Smith asked that if the winds were above the limits for arriving from the north would activity in the restricted area be suspended to allow the aircraft to arrive from the south or would the aircraft still come in from the north? Bob replied that the restricted area would still be active and the aircraft would have to come in from the south at a reduced rate. Shane also asked if there had been any determinations made regarding the UPS crash in Birmingham. Bob said he thought that NTSB had recently finished their report and he should search for it on the internet. Bill Wilson asked some questions about the Phase 3B issue and wanted to know if the Audubon Park easement issue was an administrative process or court process. Mary Rose responded that she is the Mayor of Parkway Village and they have the same kind of Code Enforcement Board as Audubon Park and that if you get a citation and don't like it you can go to the code enforcement board. If they rule you are guilty and owe a fine then your next process is to go to Jefferson District Court to appeal the Code Enforcement Board. He also wanted to know who the point of contact is for the Quieter Homes program. Bob gave him Wendy Harrower's name at the Quieter Home office.


Monthly Contraflow September 1-30, 2014






Monthly Contraflow October 1-31, 2014






Comment Type* (SDF and LOU)






Daily Runway Use Uncorrected (SDF) September 2014






