- I. Call to order: The meeting was called to order at 6:00 p.m. by John Sistarenik.
- II. Approval of the September 26, 2022, Minutes: The September meeting notes were reviewed with no changes and approved.
- III. Active Noise Cancellation Grant Update: Bob reported that on August 22, 2022 the LRAA received a grant officer of \$300,400.00 for the Airport Environmental Mitigation Pilot Program to Install an Active Noise Control system to reduce aircraft noise from start-of-takeoff operations. With the LRAA match the total for the project will be \$600,800.00. We are currently working out contractual issues with the consortium (LRAA, HMMH, National Institute of Aerospace (NIA) and FAA).
- **IV. Airspace Project Update:** Bob reported that the FAA meeting to review the proposed procedures and next steps is scheduled for Friday, December 2<sup>nd</sup>.

#### V. Part 150 NCP:

A. Noise Insulation Program: Residential – This project is to sound insulate residences within the DNL 65 contour according to the 2021 Noise Exposure Map. Construction is complete for the first 3 groups of 105 families. A contract has been awarded for a 4<sup>th</sup> group of 20 families which is currently in the material procurement process. A project for an additional 33 families was awarded at the board meeting in April and is in the process of getting the contract executed. Designs for an additional 30 families are completed. A grant offer for \$13.1 million was received on September 2, 2022. This includes the \$4.6 million announced in July. With the LRAA match, the total will be \$14.4 million for the continuation of the current sound insulation program. A draft EA has been completed and was posted for Public comment.

The public comment period ran from October 26 through November 25<sup>th</sup>. Once the FAA reviews any comments, we expect the FAA will issue a Finding of No Significant Impact (FONSI).

**B.** Contraflow Exceptions: Contraflow for September was 91% for arrivals from the south and 75% for departures to the south. In October arrivals from the south were 60% and departures to the south were 83%. Daily summaries for each month are contained in the handout. For calendar year 2022 arrivals from the south are 68% and departures to the south are 78%. The two-year average for Contraflow is 66% for arrivals from the south and 76% for departures to the south. A monthly summary going back 8 years is included in the handout.


#### VI. Current Noise Concerns:

- **A.** Report on Noise Concerns/Complaints: A total of 74 comments from 8 individuals were received in September. In October, 108 comments from 14 individuals were received. Comments and locations are contained in the handout.
- **B.** Runway Utilization: Runway utilization for September and October are contained in the handout. Daily runway utilization comments from the Air Traffic Control Tower for September and October are also included in the handout.
- C. <u>Construction and Maintenance Activity</u>: Brian Sinnwell reported that the pavement repair work on runway and taxiways has wrapped up and is calm right now before peak season. Construction will begin again around late April or early May. There could be some intermittent closures after January 15 due to an electrical project. Overall construction projects should be really light over the next few months.

- VIII. Announcements: Mary Rose Evans announced that last Saturday the Airport Neighbors Alliance (ANA) elected her to be the ANA representative on CNF since she is no longer on the LRAA Board of Directors. She is replacing John Sistarenik, who is now the LRAA Board representative. Rachel Roarx informed the group that the Metro Council District 21 office is starting to field more questions regarding the construction of the UPS maintenance hangar. Rachel also announced that she will be in a new role next year as the State Representative for a portion of the South Louisville area. Metro Councilwoman George will be Citizen George and Rebecca Katz will be the representative from the office that will stay connected with the group.

#### Monthly Contraflow November 1-30, 2022








#### Monthly Contraflow December 1-31, 2022






#### Contraflow This Year As of December 31, 2022




Total, New, and Individual Comments (SDF/LOU)




Total, New, and Individual Comments (SDF/LOU)



#### Operations and Landing (SDF)







