In accordance with 49 CFR Part 26, the Louisville Regional Airport Authority ("the Authority) is providing notice of its DBE Participation Goals for the FFY 2022-2024 Triennium for Construction Projects Louisville Muhammad Ali International Airport and Bowman Field. In accordance with 49 CFR 26.51(c)(5)(ii) and (d) the Authority established the goals for utilizing an Alternative Method and based its methodology upon demonstrable evidence of local market conditions. This method ultimately attains a goal that is rationally related to the relative availably of ACDBEs in the market area.

The Louisville Regional Airport Authority utilized its Bidders lists to examine the relative availability of DBEs in the market area, as well as a review of the DBE directories. Based upon the historical review of three years of Goal Accomplishment data, the Authority believes an adjustment of the base goal is warranted, by taking the median of the past three years of Goal Accomplishment (15.7%), adding it to the base goal of 12.0% and then averaging the two. 12.0% + 15.7% = 27.5% / 2 = 13.75%.

Breakout of Estimated "Race and Gender Neutral" (RN) and "Race and Gender Conscious" (RC) Participation

Louisville Regional Airport Authority will meet the maximum feasible portion of the overall goal by using race neutral means of facilitating DBE participation. Means we will undertake include:

- 1. Arranging solicitations, times for the presentation of bids, quantities, specifications, and delivery schedules in ways that facilitates DBE, and other small businesses, participation.
- 2. Providing technical assistance and other services.
- 3. Carrying out information and communications programs on contracting procedures and specific contract opportunities.
- 4. Implementing a supportive services program to develop and improve immediate and long-term business management, record keeping, and financial and accounting capability for DBEs and other small businesses.
- 5. Providing services to help DBEs and other small businesses improve long-term development, increase opportunities to participate in a variety of kinds of work, handle increasingly significant projects, and achieve eventual self-sufficiency.
- 6. Ensuring distribution of DBE directory, through print and electronic means, to the widest feasible universe of potential prime contractors.

Louisville Regional Airport Authority estimates that in meeting the established overall goal of 13.75%, it will obtain 1.3% from RN participation and 12.45% through race conscious measures.

Louisville Regional Airport Authority expects to award at least one contract to a DBE prime contractor through competitive bid procedures. This contract, an airfield lighting project is expected to represent at least 1.3% of the FAA-funded work during this goal-setting period. Therefore, 1.3% of the 13.75% goal is expected from race-neutral means, and the remaining 12.45% is expected to be race-conscious participation.

However, as required by 49 CFR 26.51(f)(4), the Louisville Regional Airport Authority must make an adjustment to a yearly goal if it exceeded its overall goals for two consecutive years. A review of the data reveals that the Authority did exceed its contract goals for 2022 and 2023 by an average of 84% in its use of contract goals. Accordingly, the regulation requires that for the year after those two consecutive years at issue, the Authority reduce its contract goals by the same proportion that it exceeded them. As it stands, simply based upon the weighted goals for the projects for the Fiscal 2024 year, the goal is set at: 12.7%. 84% of 12.7 is 10.6%, therefore, a 10.6% reduction to the goal must be made:

Accordingly, for the Fiscal Year 2024, the Goal is 12.7% with 2.10% by race conscious means and 10.6% by Race Neutral means

Louisville Regional Airport Authority will adjust the estimated breakout of race neutral and race conscious DBE participation as needed to reflect actual DBE participation (see §26.51(f)) and track and report race neutral and race conscious participation separately. For reporting purposes, RN DBE participation includes, but is not necessarily limited to the following: DBE participation through a prime contract obtained through customary competitive procurement procedures; DBE participation through a subcontract on a prime contract that does not carry a DBE goal, DBE participation on a prime contract exceeding a contract goal, and DBE participation through a subcontract from a prime contractor that did not consider a firm's DBE status in making the award.

# **Consultation**

In establishing the overall goal, Louisville Regional Airport Authority provided for consultation and publication. This process included consultation with minority, women's, and general contractor groups, community organizations, and other officials or organizations which could be expected to have information concerning the availability of disadvantaged and non-disadvantaged businesses, the effects of discrimination on opportunities for DBEs, and the Louisville Regional Airport Authority's efforts to establish a level playing field for the participation of DBEs. The consultation included a scheduled, direct, interactive exchange with as many interested stakeholders as possible focused on obtaining information relevant to the goal setting process, and was conducted before the goal methodology was submitted to the operating administration for review. Details of the consultation are as follows.

The consultation engaged in was via video teleconference which was held via Zoom on May 1, 2024 at 2:00 p.m..

No comments have been received to date.

A notice of the proposed goal was published on the Louisville Regional Airport Authority official website before the methodology was submitted to Federal Aviation Administration.

If the proposed goal changes following review by Federal Aviation Administration, the revised goal will be posted on Louisville Regional Airport Authority official website.

Notwithstanding paragraph (f)(4) of §26.45, Louisville Regional Airport Authority proposed goals will not be implemented until this requirement has been met.
