RE: Amended Notice of DBE Participation Goals 2024-2026, after FAA Guidance

In accordance with 49 CFR Part 26, the Louisville Regional Airport Authority ("the Authority) is providing notice of its amended DBE Participation Goals for the FFY 2024-2026 Triennium for Construction Projects at Louisville Muhammad Ali International Airport and Bowman Field. These goals were amended after review by the FAA Office of Civil Rights. In accordance with 49 CFR 26.51(c)(5)(ii) and (d) the Authority established the goals for utilizing an Alternative Method and based its methodology upon demonstrable evidence of local market conditions. This method ultimately attains a goal that is rationally related to the relative availably of DBEs in the market area.

The base goal projection after weighting is as follows:

Dividing the weighted DBE totals by the total estimate for all trades gives a base DBE availability figure for the projects anticipated during the goal-setting period. This figure is expressed as a percentage and serves as the basis for the three-year overall goal.

Base of DBE Goal: 6.0%

## **Adjustment**

The Louisville Regional Airport Authority utilized its Bidders lists to examine the relative availability of DBEs in the market area, as well as a review of the DBE directories. Based upon the historical review of three years of Goal Accomplishment data, in the chart below, the Authority believes an adjustment of the base goal is warranted. This adjustment was made by taking the median of the past three years of Goal Accomplishment (15.7%), adding it to the base goal for year three of 6.0 and then averaging the two. 6.0% + 15.7% = 21.7% divided by 2 = 10.85%. The same process was used to adjust the base goal for each of the remaining years of the triennium, year 1 and year 2 and those adjusted goals for each of the three years was averaged to determine the goal for the triennium as a whole. (10.60+11.10+10.85) = 32.55% divided by 3 = 10.85%

# Breakout of Estimated "Race and Gender Neutral" (RN) and "Race and Gender Conscious" (RC) Participation

Louisville Regional Airport Authority will meet the maximum feasible portion of the overall goal by using race neutral means of facilitating DBE participation.

- 1. Arranging solicitations, times for the presentation of bids, quantities, specifications, and delivery schedules in ways that facilitates DBE, and other small businesses, participation.
- 2. Providing technical assistance and other services.
- 3. Carrying out information and communications programs on contracting procedures and specific contract opportunities.
- 4. Providing services to help DBEs and other small businesses improve long-term development, increase opportunities to participate in a variety of kinds of work, handle increasingly significant projects, and achieve eventual self-sufficiency.
- 5. Ensuring distribution of DBE directory, through print and electronic means, to the widest feasible universe of potential prime contractors.

The Louisville Regional Airport Authority has exceeded its goals for more six consecutive fiscal years. This may indicate that DBEs may be able to compete for and obtain projects without race conscious contract goals. Accordingly, the Authority is moving to race neutral means to meet its triennial goal of 10.85% and will not set contract goals. The Authority will monitor this approach throughout each year of the triennium and adjust should it become necessary. If in any year the Authority begins to set contract goals, it will maintain data separately on DBE achievements in those contracts with and without contract goals, respectively. For reporting purposes, RN DBE participation includes, but is not necessarily limited to the following: DBE participation through a prime contract obtained through customary competitive procurement procedures; DBE participation through a subcontract on a prime contract that does not carry a DBE goal, DBE participation on a prime contract exceeding a contract goal, and DBE participation through a subcontract from a prime contractor that did not consider a firm's DBE status in making the award.

## **Consultation**

In establishing the overall goal, Louisville Regional Airport Authority provided for consultation and publication. This process included consultation with minority, women's, and general contractor groups, community organizations, and other officials or organizations which could be expected to have information concerning the availability of disadvantaged and non-disadvantaged businesses, the effects of discrimination on opportunities for DBEs, and the Louisville Regional Airport Authority's efforts to establish a level playing field for the participation of DBEs. The consultation included a scheduled, direct, interactive exchange with as many interested stakeholders as possible focused on obtaining information relevant to the goal setting process, and was conducted before the goal methodology was submitted to the operating administration for review. Details of the consultation are as follows.

The consultation engaged in was via video teleconference which was held via Zoom on May 1, 2024 at 2:00 p.m. No comments were received.

A notice of the proposed goal was published on the Louisville Regional Airport Authority official website before the methodology was submitted to Federal Aviation Administration.

If the proposed goal changes following review by Federal Aviation Administration, the revised goal will be posted on Louisville Regional Airport Authority official website.
